## A message from our President, Khal Slayhi

2012 was a relatively quiet year for Rutherford due in most part to the fact we were able to do so much the previous year with the overwhelming generosity & support that was forthcoming from our members.



Our Grounds Committee team of Tim Kruse and Ron Johnson are working on plans for improvements to the grounds. Some are needed from a safety aspect and others to beautify the grounds. Of course any changes are always dependent on funds and so again I send a plea to each of you to consider a donation to the Rutherford Cemetery. All donations are tax deductible and you can direct donations to a specific fund, i.e. a replacement trees.

In September I attended the 3-day Annual Convention of the MN Association of Cemeteries. This was a most interesting event and one of the discussions centered around what lot owners should know about cemetery law. Much confusion exists in the minds of lot owners and their families concerning their legal rights relating to cemetery lots. In many ways the operation of cemeteries differs from the ordinary tasks of administration of business affairs or government, although it is somewhat similar to both. This peculiar relationship is the reason for the existence of many of the laws affecting cemeteries, which quite often seem to be the reverse of the usual rule. I'd like to share with you just a few that were mentioned:

- *What The Purchaser Buys*: Cemeteries are allowed to grant to lot purchasers only the right to burial, and that is the only title, which a lot owner acquires when the lot is conveyed, no matter what form or deed be used. [MN Statutes (306.09)]
- *Burials Restricted*: The law expressly forbids the burial of anyone on a lot who was not at the time of death, the owner of the lot, or a relative of the owner by blood or marriage, except by written consent of the cemetery. [MN Statutes (306.29)]
- *Taxes, Mortgages, Etc.* Lot owners cannot mortgage their lots; neither does the law tax them, nor allow them to be taken away from the owner to pay his debts. [MN Statutes (306.29)]
- *Limitations In Deeds*: Cemeteries are permitted by law to adopt rules and regulations for their government, and their deeds of burial lots may be made subject to such rules and regulations. [MN Statutes (306.09)]
- *Rules*: Every modern cemetery has in force rules and regulations governing, amongst other things, planting or landscaping, monumental work, burials, removals, conduct of visitors, speed of vehicles, etc. Lot owners are subject to all reasonable control by the cemetery in such matters, both by force of law as well as by the terms of the deeds by which their lots are conveyed to them. [MN Statutes (306.02) (306.25) (306.08) (306.09) (306.73)]

This coming Annual Meeting will be my last as President of this fine Association. I would like to take this opportunity to thank you all for giving me the opportunity to represent you for the past three years. It has been most rewarding and I know my successor will also get a great deal from the experience. I would like to encourage each and everyone one of you to consider taking an active part on the Board or one of the Committees. Just contact any Board Member for information.

In closing, I once again send a most sincere *thank you* to all of you who have so generously made donations, whether it is giving your valuable time, services, goods or money. It is because of *you* that Rutherford Cemetery will continue to be successful and given these are still tough financial times, we are honored that you consider the Association a worthy cause. We can't thank you enough.

### A Reminder.....

Flowers and plants may not be planted on grave sites and no artificial plants are permitted. It is important that everyone is aware of the governing rules of the Rutherford Cemetery Association. You'll find a copy of the current Rules & Regulations in this Newsletter as well as on the website.

## The Priscilla Club would have turned 100 in 2013. So for a little trip down memory lane, here is a story that was published in 1963 as the Club turned 50.

#### PRISCILLA CLUB HISTORY: 1913 - 1963

The people of the Rutherford settlement and the Twin Lakes area, thru the years, have had many ties: friendship, relationship, and a desire for companionship ever since the days of the early settlers.

Beside individual visiting and special occasions, as birthday parties, wedding anniversaries and picnics, there was a non denominational Sunday school during the infant years of this century which proved to be the leaven which increased the well being of these two communities.

It was not until 1913 that the thought of gathering regularly was brought into focus.

In June 1913, Mrs. Ned Benschoter, a comparatively new settler in the Rutherford district, invited the women from both these areas to her home for a potluck dinner. (NOTE: a hand-written note on this document indicates that the "First meeting was held at H.B.Vollmer's home on June 11, 1913").

With no thought of officers or elaborate rules but by mutual consent, these dear folks agreed to meet every two weeks on Wednesday at various homes. As the men seemed to be the minus quantity, it was not long before they were included in every fourth meeting.

These gatherings were soon called the Wednesday Club and later on became known as the Sewing Club. This name came into being because either individuals brought hand sewing or came prepared to sew for the hostess or someone else.

It was not until the January 1915 meeting these women decided it was time to have a permanent name, some needed rules, and officers. After much amiable discussion and suggestions of names, a vote was taken and Priscilla, proposed by Mrs. Frame, was selected. To complete the business at hand, officers were elected and rules adopted. Mrs. Delbert Wilcox became the first president of the now two year old club.

From that day forward, the Priscilla Club became an integral part of the community life. Whenever sickness or trouble of any kind manifested its ugly head, the Priscillas were there to do their bit to give that spark of encouragement needed to dissipate the dark cloud.

Progress has a way of changing the status quo. As daughters grew up and were ready to start new homes of their own, the Priscillas gave a shower and presented the bride with remembrances for her new home.

The cries of war in 1917 roused the Priscillas to do their part and more for home and country. Like minutemen in days of yore, they sewed and knit, bought bonds and saved food.

In the spring of 1918 they sponsored a dance for the benefit of the Red Cross, held in Clarence Newman's comparatively new barn, the largest barn in this vicinity. This enormous project enabled the Priscillas to turn over five hundred and sixty-four dollars to the Red Cross. For this occasion, Harriet Rutherford made a large two layer white fruit cake. Chances were sold and eighty-four dollars was realized from this venture.

Peace brought many changes. People moved in and out of our communities, but this club survived and kept going.

In 1921, Washington County had its first county agent and our alert members invited him or his fellow field workers from the University of Minnesota to many meetings. From that time until the present day, the Priscillas have been partners with the extension department to better conditions of home, farm and community.

Approximately three years after these ventures, there were many more changes in the Twin Lakes area than in the Rutherford neighborhood. The newcomers to that part of our county who replaced the old timers felt the need of their own club. As a result there was a gradual recession of those members.

Undaunted the Priscilla Club forged on, taking in daughters and daughters-in-law of original members and also gladly welcomed the new people who came to live in the Rutherford district. Even today this is our club's policy.

To commemorate our fifty years of useful, cultural, and companionable existence, we, the Priscillas, in 1963 have endeavored to depict our history by making a quilt to rest in the archives of Washington County, the Historical Museum in Stillwater.

#### **PRISCILLA CLUB HISTORY – continued**

#### <u>The Quilt</u>

In this quilt we hope you can read some of our history. Around the Priscilla are ten project blocks. Each block was made by a member who generously offered to do her part in her own way to tell the story of the past fifty years of this club's history.

#### The Ten Blocks

One block depicts our original potluck meetings and also our annual picnics. The annual picnic is held usually in July for all the folks in each household of each member, also for special friends, together with former members.

Another tells we have generously supported many local projects: needy families, youth organizations, city rest room, and community chest. Then, too, we have contributed to many state and national funds.

Of course, we had to tell about the wedding showers given at first for the daughters. Later we gave the sons this same consideration.

The Priscillas have been generous contributors to the Sister Kenny Project each year, by sewing, making cookies, and also making or contributing to the toy fund. This part of our history, we hope, is shown by a simple appliqué picture of that worthy lady.

Our many years of service under the guidance of the extension workers from the University is simply marked "Homemakers".

The piles of pajamas sewed for the Red Cross, during the first World War, along with the dozens of knitted sweaters and socks are not shown but instead a Red Cross nurse knitting is our way of telling that phase of our history.

You do not have to guess what the block with the red barn tells, but to make sure, this dance was our most pretentious project for the benefit of the Red Cross during the First World war.

Our anniversary party for each member as she reached one of the five year milestones is told in the block with the picture of a bride and groom surrounded by some accessories which make each wedding a memorable occasion.

Each year during the Christmas season we have had a Christmas party for the young folks in our community. The beautiful Christmas candle lights this block "Christmas Parties".

During the first World War we went along with the then prevalent procedure and adopted a French Orphan. You can see this part of our history when you find the little French girl holding up the French flag, framed with the national flower of France.

These ten main blocks are surrounded by the name blocks. Down thru the years we have welcomed and cherished one hundred and sixteen members and profited from the individuality and inspiration given our club. Most of the blocks display names denoting original members and their descendants or relatives. Others may signify the people who lived on or near a certain farm. Others are just names of friends. Just above Priscilla is the name of the grandmother, who named our club, and her family. Below Priscilla you will find the only four generation family block. We display it with pride.

As our descendants, or others, view and perhaps study this quilt as the years roll by, many of our present members may be resting in the peaceful little plot donated by one of the first settlers in the Rutherford district. It is at such times that we wish to remind you that it was at one of our Priscilla meetings where the idea of perpetual care for this plot was accidentally born.

May God bless and perpetuate the loving community spirit exemplified by the members of the Priscilla Club.

### **RCA By-Laws of the Rutherford Cemetery Association**

#### showing proposed changes to be voted on at the Annual Meeting, April 9, 2013

#### ARTICLE I

Section 1: The name of the association shall be Rutherford Cemetery Association.

#### Section 2: The purposes are:

- a. To procure and hold or sell lots exclusively for the purposes of a public cemetery.
- b. To manage all real or personal property, necessary or proper for the establishment, embellishment, care, and management of a cemetery.
- c. To sell and convey cemetery lots in the manner provided by law, and convey real and personal property lawfully acquired by the Association, but not needed for cemetery purposes.
- d. Upon adoption of these by-laws a permanent care fund will be established.

**Section 3:** The Board of Directors of said Association shall consist of President, Vice-president<mark>, Lot Sales Person,</mark> Secretary, Treasurer, and seven (7) Trustees.

Section 4: Members of said Association shall consist of lot owners and their respective families.

Section 5: All members present at Annual meetings are eligible to vote for elections and by-laws.

**Section 6:** The Annual meeting of said Association is to be held in April. Time, place, and purpose of meeting is to be distributed to all members in a timely manner.

#### Section 7: Election:

- a. Quorum. Nine (9) members shall be required for a quorum at the annual meeting of members of said Association.
- b. Vote required. A plurality vote shall be required to carry an election. A simple majority of votes cast shall be required to carry a motion.
- c. Election shall be by ballot when there is more than one nominee for office.
- d. Term of office shall be three (3) years.
- e. Officers shall be elected at the Annual meeting.
- f. The President and Vice-President shall not be eligible for re-election immediately following a three (3) year term. The outgoing President shall automatically become the seventh (7) Trustee for a three (3) year term.
- g. The Secretary and the Treasurer shall be eligible for re-election immediately following a three (3) year term.
- h. Trustee election. At each Annual meeting there shall be two (2) Trustees elected.
- i. No Trustee, President, or Vice-President, after serving for a period of three (3) years by election, or who has served or filled out one and one-half (1½) years or more of an unexpired term, shall be re-elected to the same office until one (1) year has elapsed.

Section 8: Vacancies, which may occur by resignation or other causes, shall be filled by the Board of Directors.

Section 9: Power to change By-Laws: The By-Laws, or any part of them may be changed by amendment or repeal, and adoption of new Articles at any Annual meeting thereof, providing notice of such amendment, repeal, or adoption had been stated in the published notice of Annual meeting in the RCA Newsletter Stillwater Gazette paper.

#### ARTICLE II

Section 1: The President shall:

- a. Preside at all meetings of members and at all meetings of the Board of Directors.
- b. Appoint all committees and be a member ex-officio of all committees.
- c. Call all special meetings.
- d. Prepare an agenda for each meeting.
- e. Perform all other duties pertaining to this office.

Section 2: The Vice-President shall perform the duties of the president in the absence of the president.

a. Vice-President is chairperson of the Grounds and Improvement committee and shall appoint at least two (2) members to serve on the committee.

#### Section 3: The Secretary shall:

- a. Keep a correct record of all meetings and all board meetings of the Association.
- b. Prepare all notices of annual or special meetings for distribution as appropriate.
- c. Mail notice of Annual meeting to all members.
- d. Keep record of all burial and cremation permits.
- e. Perform all other duties pertaining to this office.

#### Section 4: Treasurer shall:

- a. Receive all money of said Association.
- b. Keep an accurate record of receipts and expenditures.
- c. Pay all bills approved by the Board of Directors
- d. Shall preserve and file all papers relating to the financial affairs of said Association.
- e. Make a full report of amount and location and status of Permanent Care Fund, receipts and expenditures of Operating Fund for current year, and where and how it is kept.
- f. Have record open for inspection at all times.
- g. Perform any other duties in the interest of said Association which belong to this office.

#### Section 5: Board of Directors

- a. Meet at President's call to meetings.
- b. Meet at least two (2) weeks before the Annual meeting.
- c. Act as nominating committee and prepare a slate of nominees for all vacancies occurring at Annual meetings.
- d. Secure an outside-accredited accountant to audit the Treasure's books the terminating year of the Treasurer's term of office, prior to Board meeting.
- e. Authorize investment of Permanent Care Fund.
- f. Authorize and secure gravediggers, and establish the cost of grave-digging each year.
- g. Designate the bank location of Operating Fund.
- h. Preserve and protect the Permanent Care Fund in its perpetuity.
- i. Quorum of the Board shall be six (6).
- j. Appoint Lot Salesman.

**Section 6:** Ground & Improvement Committee: Shall consist of at least three (3) members including the Vice-President.

- a. Shall make survey of desired improvement for Annual Clean-up Day(s).
- b. See that materials, such as sod, seed, and other materials and equipment are on hand to execute a desired project.
- c. Make certain grave sites are sodded within reasonable length of time after burials.
- d. Supervise any landscaping.
- e. Supervise any removal of trees.
- f. Supervise any erection or markers of monuments.

#### Section 7: Lot Salesman

- a. Shall keep accurate record of all past and present burial sites.
- b. Shall keep accurate map of cemetery and records that pertain to it.
- c. Meet with perspective buyers as needed.
- d. After purchase, locate and record on map. Make a deed and mail to client. Get payment to treasurer.
- e. When contacted by funeral home of a death, locate grave space and mark it for the burial.
- f. Contact gravedigger and make arrangements for the grave opening if it is a regular burial. If cremation, arrange for someone to do the opening.
- g. On day of burial for cremation, lay out green carpet over the opening. Wait at cemetery until family leaves and urn is turned over to the cemetery. Cover opening and place flowers on grave.

- 1. All graves must be ground level.
- 2. All headstones must be level with the ground.
- 3. Monuments are no longer allowed on the old cemetery area. A family marker or monument, if used in the new cemetery area, is to be placed on the east end of the family lot with a ground level footing of light material extending a minimum of four inches beyond the marker on all sides.
- 4. A head stone or marker must be placed within twelve months after burial. A lot must be paid in full before a head stone or marker is placed.
- 5. All headstone bases shall be predrilled to accommodate urn stands. All urn stands must be placed in predrilled holes or adjacent to the head stone.
- 6. In case of vandalism, damage caused by the elements, common enemy, thieves, malicious mischief makers, explosions, invasion, insurrections, riots, etc. in Rutherford Cemetery, lot owners or their descendant shall be responsible for any damage incurred. If a lot owner is deceased and there are not direct descendants, Rutherford Cemetery Association will attempt to repair the damage.
- 7. Casket burial vaults shall be required in Rutherford Cemetery. They must be made of cement or a material approved by the cemetery association.
- 8. Two overburials of cremains in approved caskets or three urns will be allowed on an existing grave. No more than two cremain caskets or three urns will be allowed per burial lot. The top of said container(s) shall be no less than 18 inches from ground surface.
- 9. Burial prices: refer to Lot Salesman for current rates
- 10. Rutherford Cemetery will assess a \$15.00 transfer fee if a person sells (or gives) a lot to another person.
- 11. Twenty five percent (25%) of this amount is designated to the permanent care fund.
- 12. No artificial flowers nor flowers or plants are to be planted on the graves. The cemetery grounds committee reserves the right to remove any tree, shrub, vine, plant, flower, or any other object which may become unsightly, dangerous, or not in keeping with the landscape design of the cemetery. This also includes the placing of vases or other containers for flowers at ground level.
- 13. Annual salaries to be paid are:
  - Lot Salesperson \$200.00
  - Treasurer \$200.00
  - Secretary \$200.00
- 14. A fall meeting of the Board shall be held at the discretion of the President.
- 15. Definitions:
  - A family marker or monument is a stone designating a family lot of four contiguous lots.
  - A monument is a stone no greater than 26 inches high from the top of the cement base (which is to be at ground level) that can be used either as a family lot marker or a headstone.
  - A marker is a stone of three feet wide and no greater than 26 inches high from the top of the cement base (which is to be at ground level) that can be used either as a family lot marker or headstone.
  - A headstone is flush with the ground and will designate an individual lot but may contain multiple names.
  - A reminder to all members regarding grave markers or monuments.
  - Any marker or monument must have prior approval from the Ground and Improvement Committee before proceeding.
  - Any marker or monument must comply with the current specifications as laid down by the current Board.
